**INVITATION TO BID (RE-BIDDING) FOR THE SUPPLY AND DELIVERY OF
Laboratory Equipment for Forest and Timber Resources Research
Center (FTRRC) & Mining and Degraded Areas Resources Research
Center (MDARRC)**

1. The Ecosystems Research and Development Bureau, through the authorized appropriation for 2016 (General Appropriations and/or continuing appropriations intends to apply the sum of **Seven Hundred Twelve Thousand Pesos (712,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Laboratory Equipment. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Ecosystems Research and Development Bureau now invite bids for Supply and delivery of Laboratory Equipment. Delivery of the Goods is required within 60 calendar days upon receipt of Notice to Proceed/Approved Contract/Purchase Order. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country, the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from Ecosystems Research and Development Bureau and inspect the Bidding Documents at the address given below during office hours. Bidders may purchase a complete set of bidding documents starting October 21, 2016 from the address below upon payment of a non-refundable fee for Five Hundred Pesos (Php 500.00).
5. The Ecosystems Research and Development Bureau will hold a Pre-Bid Conference on October 28, 2016, 10:00 am at the ERDB Conference Room, ERDB, College, Laguna, which shall be opened to all interested parties.
6. Bids must be delivered to the address below on or before November 9, 2016, 10:00 am. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Eligibility check and opening of bids shall be on November 9, 2016, 10:00 am at the ERDB, Conference Room, ERDB, College, Laguna. Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.

7. The bidder shall submit two(2) copies of their duly accomplished eligibility requirements, technical and financial proposals in two (2) separate sealed envelopes to the Bids and Awards Committee at the above-mentioned address.
8. The Ecosystems Research and Development Bureau reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
