**INVITATION TO BID
FOR THE
PROPOSED FLOOR TILING OF ERDB BUILDING'S
HALLWAYS, LOBBY AND STAIRS**

The Ecosystems Research and Development Bureau (ERDB), through the General Appropriations Act intends to apply the sum of PESOS ONE MILLION NINE HUNDRED THIRTY NINE THOUSAND ONE HUNDRED SEVENTY EIGHT and 76/100 (P 1,939,178.76) being the Approved Budget for the Contract (ABC) to payments under the contract for the above project. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Works are required for 45 calendar days. Bidders should have completed a contract similar to the Project within ten (10) years from the date of submission and receipt of bids. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

An open competitive bidding will be conducted using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from ERDB and inspect the Bidding Documents starting Nov. 2, 2015 to Nov. 22, 2015 and purchase the same from the BAC Secretariat upon payment of a nonrefundable fee in the amount of ₱ 2,000.00.

A Pre-Bid Conference will be conducted on Nov. 11, 2015, 2:00 pm at ERDB.

Bids must be delivered on or before Nov. 23, 2015, 2:00 pm at ERDB. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.

The ERDB reserves the right to 1) reject bids, 2) declare a failure of bidding, and 3) not to award the contract without incurring any liability if the funds/allotments for said program/project/activity have been withheld or reduced through no fault of ERDB. ERDB further reserves the right to waive any formality in the response to the eligibility requirements and to this invitation.
