**INVITATION TO BID FOR**  
**Supply, Delivery and Installation of ICT and Laboratory**  
**Equipment for the IMPROVEMENT OF FOREST TREE**  
**SEED FACILITY OF MINDANAO TREE SEED CENTER**  
**(MTSC) in**  
**Maharlika, Bislig City Surigao del Sur**

The Ecosystems Research and Development Bureau (ERDB), through the General Appropriations Act of 2020 intends to apply the sum of **Four Million Three Hundred Seventy Nine Thousand One Hundred Forty Pesos (₱ 4,379,140.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the above project. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The Ecosystems Research and Development Bureau now invites bids for **Supply, Delivery and Installation of ICT and Laboratory Equipment for the IMPROVEMENT OF FOREST TREE SEED FACILITY OF MINDANAO TREE SEED CENTER (MTSC)** Delivery of the Goods is required within **90 to 120 calendar days** upon receipt of Notice to Proceed/Approved Contract/Purchase Order. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- Interested bidders may obtain further information from **Ecosystems Research and Development Bureau** and inspect the Bidding Documents at the address given below during office hours. A complete set of Bidding Documents may be acquired by interested Bidders on **September 9, 2020** from the address below and upon payment of the of a non-refundable fee for the Bidding Documents in the amount of **Php 4,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- The **Ecosystems Research and Development Bureau** will hold a Pre-Bid Conference on **September 18, 2020** thru **ZOOM Video Conferencing platform** at 10:00 AM which shall be open to prospective bidders.
- Bids must be duly received by the **BAC Secretariat** at the address below **or send thru email (PDF Format)** on or before **September 30, 2020 at 10:00 am.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Eligibility check and opening of bids shall be on **September 30, 2020 at 10:00 A.M. thru ZOOM Video Conferencing.** Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.

- The bidder shall submit two (2) copies of their duly accomplished eligibility requirements, technical and financial proposals in two (2) separate sealed envelopes to the Bids and Awards Committee at the above-mentioned address.
- The **Ecosystems Research and Development Bureau** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
